




### **Construction Projects**

- Project 3: Terminal Reconfiguration
- Project 4: Airport Operations Building



### Project 1 – Taxilanes

- Work scheduled to resume in mid-April
- Hangar paving will take place during Project 2 closure
- Project was briefed to hangar owners on 2/26



## Project 2 Update

- No major issues during bidding
- Open bids March 13, 2:00 pm
- Recommendation of award at March 20 meeting


- Mar. 3 Open Bids

#### Project 5 Terminal Apron/Site Preparation

Scope of Work

- Design
  - Terminal apron
  - Terminal addition site preparation
  - Airport Ops Building site preparation
  - North taxilane and apron
- Construction
  - All elements, except for paving of apron and taxilane



#### Project 5 Terminal Apron/Site Preparation

Schedule

- March: Fee negotiation
- April-May: Design
- June July: Bid
- August October: Construction



## **Facility Acquisitions**

- Review appraisals underway
  - Should be received by late March
- Negotiation process will follow
- Discussions with USFS are ongoing, regarding their needs



### **Grant Application**

- Grant application has been prepared
- Includes all work planned for FY '14:
  - Projects 2-5
  - Facility Acquisitions
- Total project value: \$24 million
  - FAA Share: \$22.5 million
  - Airport Share (PFC): \$1.5 million



## **Grant Application**

- Actual amount of grant may vary
- If inadequate funding is available in FY '14, portions of projects will be funded in FY '15
- FAA may elect to issue multiple grants
- Board action requested:

Authorize staff to process grant application and initiate grant acceptance process with both sponsors?



## Master Plan Scope of Work

- SOW deferred pending City of Hailey review and discussion
- Airport Staff planning to present the SOW at the April regular Board meeting, based on prior City of Hailey Airport Master Planning discussion
