


#### We have made great progress...

- ✓ 3 new flights-DEN, PDX, SFO (+LAX, SEA, SLC)
- ✓ New airline United
- ✓ New regional jet service on United, Delta
- ✓ More seats to all 6 cities; longer seasons
- √ 40,000+ new air-travel visitors; spending \$55M
- √ \$340M total in direct spending by visitors and part-time residents
- \$200M overall economic impact from tourism developments (hotels, airport, etc.) and new visitor spending
- ✓ Airfares decreased by an average of 10%








#### SUN AIR SERVICE SEATS & ENPLANEMENTS

SUN air service showing strong recovery






#### **SUN AIR PASSENGER MIX**

- > Retain contracted nonstop SEA, LAX, SFO, DEN, PDX (+SLC) flights





Recommend Awarding Schedule C

#### Apron/Parking Strategy

- ▶ Knife River's bid is responsive
- Price is extremely high
  - High demand in Southern Idaho
  - Subconsultants are very busy
- Exceeds budget

#### **Apron/Parking Options**

- Option 1: Negotiate with Knife River
  - Reorganize schedule
    - Parking lot Fall 2017
    - Apron Spring 2018
  - Goal: Relax schedule and reduce risk
  - Advantages
    - · No re-bid
    - Cash flow

#### Apron/Parking Options

- Option 2: Re-bid
  - Open bids Mid–June
  - Parking Lot Fall 2017
  - Apron Spring 2018
  - Alternate: Bid in Winter 2018, build with similar schedule as this year
  - Advantages:
    - Competition
    - Cash flow
    - Opportunity to acquire Snow Removal Equipment

#### Apron/Parking Recommendation

- Move forward with award of Schedule C
- Discuss renegotiation with Knife River (one week)
- Re-bid, with bids open in early- to mid-June
- Construct parking improvements in Fall 2017
- Construct apron expansion in Spring 2017
- Proceed with acquisition of snow blower for delivery by December

# Apron/Parking

Board Action Requested

Authorize award of Schedule C to Knife River Corporation – Northwest. Authorize Staff and Consultants to negotiate with Knife River Corporation – Northwest on remaining schedules. If progress is not made within one week, proceed with re-bidding the project, with the goal of opening bids by mid–June.
