- Multi-Task Equipment (MTE)
 - Needed to replace aging equipment and enhance fleet
- "Piggyback" on Idaho Falls Bid
 M-B Companies
- Included in FY20 CIP
- FAA supports acquisition

- \$680,114
 - 300 day delivery schedule
- AIP eligible at 93.75%

- Soliciting quotes for new tractor
 Legal review
- Delivery required by Sept. 30

 - Parking lot





Terminal Area Plan

- Scope of Work
 - Mead & Hunt
- Deliverables
 - Terminal improvement options and phasing
 - Parking lot improvement options
 - Revised forecasts of demand
 - Funding options and CIP
- Schedule
 - Approximately 9–12 months

- FAA supportive
 - In CIP for FY2020
 - \$100,000
 - AIP eligible at 93.75%
 - Will have to front funds before available grant funds
