## Primary Job Responsibilities:

- Help and inform passengers in need
- Respond to the public with courtesy and good will
- Answer general questions, provide directions, as well as local area maps
- Communicate with Airport Operations team regarding safety or security issues
- Assist with local hospitality events in the terminal
- Pick up of trash and debris to ensure cleanliness inside and outside of the terminal area.
