Caldwell Transportation Company – Bussing Contract

- Fixed cost bussing services
 - Ensures all bussing equipment and operators are on standby for diversions to/from Twin Falls and Boise
 - ALL airline operators at SUN (current and future)
 - ALL inbound and outbound SUN passengers
- Partnership with FSVA
 - \$180,000
 - Typically a FSVA expense
 - Anticipated higher MRG costs
 - Anticipated lower LOT revenues
- Airport Budget and CARES Act
 - Provides flexibility to be an airport expense
 - FY'21 only
 - Coordinated with the Finance Committee



Caldwell Transportation Company – Bussing Contract

 ACTION: Motion to approve contract with Caldwell Transportation Company in the amount of \$180,000 for FY'21 fixed cost bussing services



Recommendation of Award - MB5

- Multi-Task Equipment (MTE)
 - Continued enhancement/replacement of SRE fleet
 - Similar unit delivered in September of 2020
 - High Performance
 - "Force-multiplier"





Recommendation of Award - MB5

- MB Companies
 - Honor same contract and contract price
- ▶ \$684,213 (including Change Order)
 - Local funds for procurement
 - Expedient
 - Cost effective
- ▶ 10–11 month delivery
- ▶ ACTION: Motion to approve Recommendation of Award to MB Companies in the amount of \$684,213 for the procurement of an MB5 MTE




