Airport Activity Status

- April/May Passenger Enplanements
 - -35% over April 2021
 - $^\circ$ –57% over May 2021
 - +24% YTD vs. 2021
- Operations (unofficial)
 - -59% from May 2021
 - ∘ −16% YTD vs. 2021

CUSTOMER FACILITY CHARGE (CFC)



CFC – What & Why

- A Customer Facility Charge (CFC) is a user fee imposed by an airport operator on each rental car user, collected by the rental car companies.
- A CFC is most often imposed on a per rental day basis and often has a cap on the number of days the CFC will be charged.
- CFC revenues are used for the capital costs related to rentalcar projects.
 - Allows for a dedicated funding source for projects that are not eligible for federal funds.
- The proposed fee is \$3.50/rental day capped at 14 days ° Estimated revenue of \$210k per year



CFC – Resolution 2022–01

- Consideration of Resolution 2022–01 implementing the CFC
- Current rental car agreements allow for implementation of a CFC
 - Rental car agencies supportive
 - Collection begins October 1, 2022
- Discussion
- Action: Motion to approve Resolution 2022–01 authorizing the collection of a CFC at SUN. Further, per legal counsel guidance, amend the 2021 Rental Car Concession Agreements as necessary and direct staff to implement the remaining administrative functions to begin CFC collections as of October 1, 2022.

General Budget Build Notes

- Historical data is important, however recent history is still slightly skewed and increases are expected
- Projections will lean financially conservative rather than being overly aggressive
- Activity is anticipated to continue to increase off already record levels
- CPI is used for increases when applicable for contracts



OPERATING BUDGET



FY 2023 Revenues

- Continued growth post COVID
- Revenues built based on enplaned passengers in excess of 100k
- No discount planned for Terminal rents
- Revenue budgets were heavily weighted on recent history given the effect of the pandemic on prior years
- Hanger/Tie-down revenue steady, utilizing CPI when the contracts allow
- Draft Budget assumes \$2.0 million in CARES Act operational reimbursement

FY 2023 Expense (Administrative)

"A" Expenses (Salary/Benefits)

- 5% annual increase for COLA and Merit
- Additional Ops Staff for In-House parking operations
- Assumes Airport staffing at 100%

"B" Expenses – Administrative

- Business travel anticipated to return
- Professional Services needs
 - Increased legal need based on recent historical use (6050-01)
 - Elevated budget for IT Support based on recent historical spending, system needs and cost of services (6050-10)
 - Approach Maintenance & Refinement with Flight Tech (6050-18)
- ARFF Training increase due to the extra position and training needs (6100-03)
- Large reduction in Parking Management Fees (6110-16)
- Remaining expenditures are anticipated to align closely with historical needs with appropriate cost increases



FY 2023 Expenses (Operations)

• "B" Expenses – Operations

- Overall increase in operations supplies/equipment due to noncapital equipment needs
- Increase in Tools budget, staff is completing more repairs in-house, saving outside contract costs (6500-02)
- Total increase in Vehicle Maintenance budget due to fleet growth (Total 6520-00)
- Total increase in Building Repairs & Maintenance (Total 6540-00)
 - Terminal R&M, expecting increased occupied space in FY 2023
 - Shop garage door rehab, needed workspace improvements, aging equipment
- Total increase in Airside R&M due to increased chemical costs
- Total increase to Security expenses due to enhancements and upgrades needed.
- Remaining expenditures are anticipated to align with historical needs with appropriate cost increases


