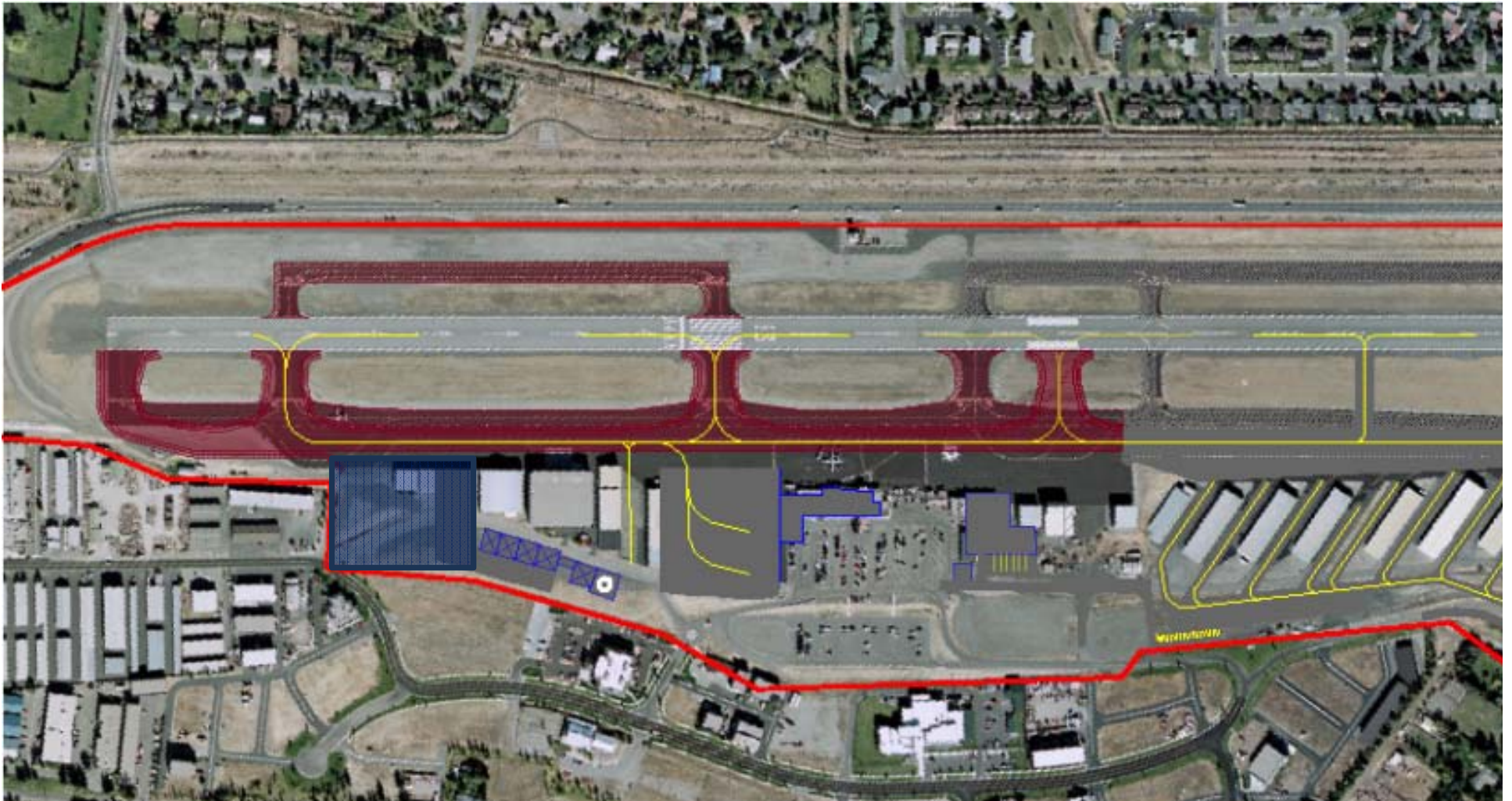

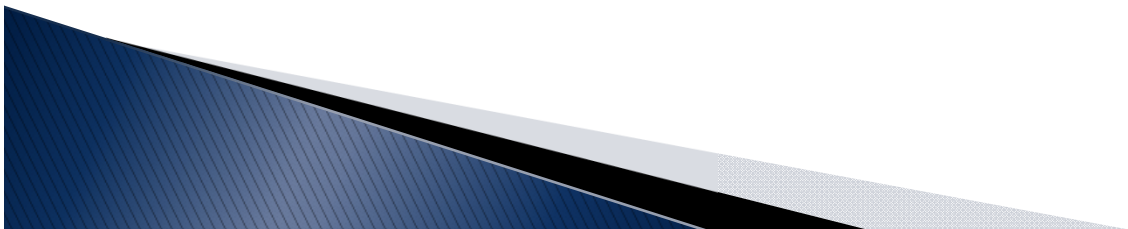
Project 6 – Rebid

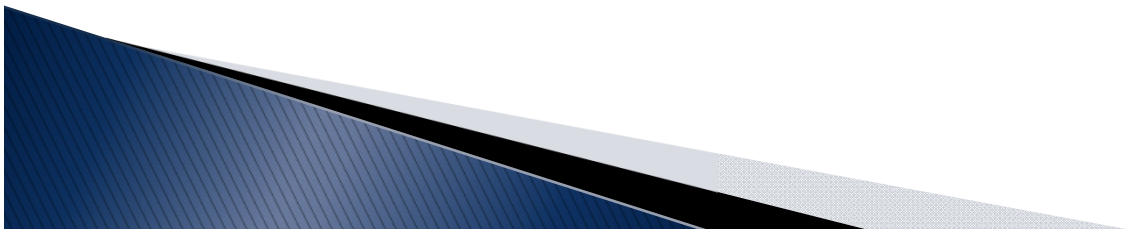

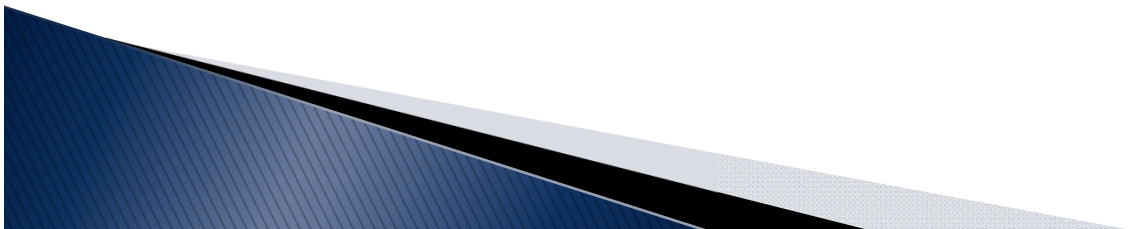
Project 6 – Award

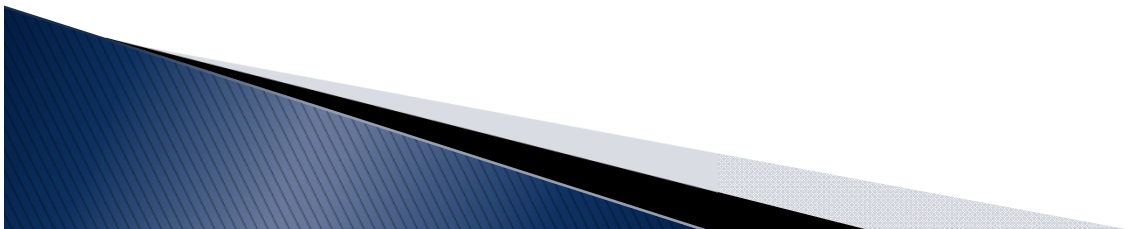
