ITD Division of Aeronautics Grant Offer – Consideration of Approval – Attachment #9 - #12
 ACTION ITEM

The Idaho Transportation Department, Division of Aeronautics, has extended a grant offer to the airport in the amount of \$450,000, administered through the Idaho Airport Aid Program (IAAP).

In addition to recommending acceptance of this grant offer, Airport Staff seek Board support and discussion on using these funds to explore modest improvements within the existing footprint of the Airport Terminal Building and its supporting infrastructure.

Potential areas for enhancement include:

- Improvements to the single-lane TSA screening checkpoint, and
- Upgrades/improvement to the single CT80 checked baggage screening machine.

For reference, current screening capacities are limited to approximately 150 passengers per hour and 100 checked bags per hour, respectively. Staff believe there are creative, space-efficient solutions that can improve throughput without requiring major renovation. While we recognize that these improvements may serve as a temporary "band-aid" rather than a long-term solution, staff will do their best to ensure that any enhancements made are thoughtful, scalable, and represent a meaningful investment in both the near-term customer experience and the airport's long-term efficiency.

The focus will be on evaluating design modifications aimed at improving customer experience and operational efficiency. Staff propose engaging Ardurra, along with their architectural subcontractor(s), to evaluate layout options and provide design concepts.

ACTION REQUESTED:

Motion to recommend acceptance of the ITD Division of Aeronautics Grant Offer in the amount of \$455,000 by the City of Hailey and Blaine County as airport co-sponsors. The actions will further direct Staff and Legal Counsel to develop the appropriate City and County Resolutions to support acceptance of the ITD Division of Aeronautics Grant Offer.

B. Continuing Business

GA Pilot Lounge Contractor Selection – Consideration of Award – Attachment #13 ACTION
 ITEM

In accordance with FAA Guidance, a sealed bid opening was held and conducted on Wednesday, July 16, 2025 at the Airport Operations Building to select the lowest responsive bid for the construction of the GA Pilot Lounge.

The apparent low bid of \$1,250,000 was submitted by Peterson Brothers Construction, exceeding the engineer's estimate of \$1,100,000. Upon review, multiple deficiencies were identified, and after consultation with legal counsel, the bid has been deemed non-responsive for the following reasons:

- The Idaho Public Works Contractor License number listed on the bid form (RCE-9199) is inactive. Although a valid license (PWC-C-14977) was later confirmed through public records, the bid form did not reflect this.
- The required Exhibit IV DBE Utilization was not submitted as required by the Instructions to Bidders.
- Exhibit VI Buy American Certification was submitted stating 100% compliance; however, this is inaccurate. Key specified materials (e.g., security cameras and networking equipment) are not U.S.-manufactured, and compliance is not possible without a federal waiver, which was neither acknowledged nor requested in the bid.

These deficiencies violate mandatory bid requirements and cannot be waived without compromising bid fairness.

The second-lowest bid of \$1,386,125 was submitted by Conrad Brothers of Idaho, who:

- Submitted all required forms and documentation
- Holds a valid contractor license of the appropriate class,
- Properly acknowledged the need for a Buy American waiver, and
- Are eligible to receive federal funds (not suspended or debarred per SAM.gov)

ACTION REQUESTED:

Motion to Award the contract to Conrad Brothers of Idaho, Inc in the amount of \$1,386,125, contingent on FAA concurrence, availability of federal funds, and FAA approval of the Buy American waiver request.

Airport staff expect concurrence from the ADO, this week, which will allow us to formally begin the Environmental Assessment (EA) and for the FAA to program in this project for funding. As a reminder, this replacement tower will be located near the Airport Operations Building and stand approximately 80 ft tall, not including communications antennas on the roof.

Currently, the airport contracts with Atlantic Aviation to collect overnight transient parking fees with a commission of 10% of total revenue paid to Atlantic. Staff completed reference checks, virtual demonstrations, independent research, and had numerous discussions while considering the transition. The expected benefits are greater efficiency, reliability, and equitable fee assessment. Vector has agreed to match the 10% revenue share.

There was discussion of the different fee structures for landing fees versus overnight parking fees, contract termination with Atlantic Aviation, exempt aircraft, length of current contract with Atlantic Aviation, whether the transition to Vector will change the financial performance of this budget category, fractional ownership, how the new system works, and when it will be instituted.

MOTION:

Made by Board Member Greenberg to proceed with the termination of the existing contract with Atlantic Aviation for overnight parking fee collection and to enter into contract negotiations with Vector Airport Systems, seconded by Board Member Mollineaux.

Director Burke congratulated Security Manager, Steve Guthrie on his upcoming retirement. He announced that Nick Carnes has been promoted to Security Manager following Steve's retirement. Burke stated that Nick is well qualified to take on the role of Security Manager and will be shadowing Steve prior to his retirement.

Burke announced that Oliver Nordlie has been promoted to Airport Operations/ARFF Supervisor. Oliver has a Bachelor's degree in Aviation Management, is a commercially licensed pilot, and a AAAE Certified Member. Staff is excited to welcome him into the supervisor role.

Recruitment for the Deputy Director of Operations positions is underway. There has been widespread interest in the position and a supplemental interview process is underway to refine the candidate pool. Tentative interviews are scheduled for July 14. Burke is optimistic that there will be a new Deputy Director in place by late August, dependent on various factors that impact moving to a new place and beginning a new position.

Burke announced that Max Russell was hired as the eighth Airport Operations/ARFF Specialist. He has previous experience in construction and is a volunteer with Sun Valley Fire.

There was discussion about the recruitment process for Deputy Director, including who is on the hiring panel.

Director Burke announced that American Airlines has announced seasonal service to Phoenix, AZ and Chicago O'Hare. American will be using 65-seat Bombardier CRJ700 Regional Jets. Next steps include negotiating an Airline Use and Lease Agreement (AULA), negotiation and build out of ticket counters in the underutilized bussing area, and installation of an office trailer which will require Hailey P&Z review.

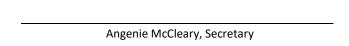

- Type of Incident (Overflight, Low Flying, Circling, Hovering, Vibration/Rumbling, Late Night/Early Morning, Sustained Noise, Frequency of Flights, Unusually Loud, Other): Unusually loud
- Comments: resident near 3rd Avenue and Bullion Street in Hailey left multiple voice messages with Airport
 Operations regarding a northbound departure over the city around 9:00 PM. The resident stated the aircraft
 was low, loud, and disruptive, and claimed the wind conditions did not warrant a northbound departure. The
 resident further demanded that the pilot be permanently banned from using Friedman Memorial Airport
 (FMA).

The Airport Director reviewed weather data and confirmed that wind conditions were calm at the time of departure and did not justify a northbound takeoff, which was inconsistent with the Airport's voluntary noise abatement program. The Airport contacted the aircraft operator to provide education on the program, informed them of the complaint, and discussed the impact of such operations on the surrounding community. The pilot was apologetic and assured the Airport Director he would brief other flight crew members on FMA's noise abatement procedures.

As a reminder, in accordance with the Commerce Clause of the US Constitution and the Airport Noise and Capacity Act of 1990, the Friedman Memorial Airport Authority's noise abatement program is strictly voluntary. As a federally funded, open-access, public-use airport, FMA is prohibited from banning, restricting, or discriminating against legal aeronautical activity.

Public Records Law

- Entries submitted without names or complaints that do not directly correlate to aircraft operations at Friedman Memorial Airport may not be considered for review.

Jurisdiction of Airspace

• The Friedman Memorial Airport Authority (FMAA) does not hold jurisdiction over federal airspace, flight plans, patterns, or paths of aircraft. The Federal Aviation Administration (FAA) has sole authority for U.S. national airspace and the regulations that govern flight operations. Consequently, FMAA cannot reroute flights, establish enforceable curfews, or discriminate against aircraft operators regardless of the time of day, aircraft type, or operation type. Air Traffic Controllers (ATC), alone, have the authority to direct aircraft into/out of airports, and pilots, alone, are responsible for ensuring that their flights, including ground

- operations, are conducted in accordance with the FAA's established regulations.
- Further, in 1990, Congress enacted the Aircraft Noise and Capacity Act (ANCA), which prohibits airports from restricting flights by time of day, frequency, aircraft type, or location. Since FMAA is an open-access, public-use airport, it *cannot* discriminate against any aircraft using this facility 24/7. To do otherwise violates the Interstate Commerce Clause of the U.S. Constitution.
- FMAA does, however, proactively manage a highly effective noise abatement program and voluntary curfew. Airport management contacts all pilots whose operations violate the voluntary curfew. The airport uses this opportunity to educate the aircraft operator on these operations' adverse effects on the community.

Subject: Atlantic Aviation charging special event fees

Hello:

I am writing as a concerned citizen and pilot that utilizes the Friedman Memorial Airport.

Within the last year or two the major FBO chains have increased both their normal handling fees and special event fees astronomically. For example, at the upcoming Allen and Co. event at Sun Valley, Atlantic Aviation will charge a special event fee of \$9368 on top of the \$2438 normal handling fee for the aircraft type that I operate. They levy this charge, but provide no additional service for doing so. In fact, the level of service during the Allen and Co. event is less than it would be normally. Our operation will most likely be limited to 30 minutes on the ground before re-positioning the aircraft to Twin Falls. We then have to pay the fees a second time in order to pick-up our passengers one day later. That level of fees is totally unacceptable.

The Friedman Memorial Airport is a recipient of FAA funding. As part of FAA funding the airport must agree to be open and available to the public. Assurance 22A of your Grant obligation states: "....will make its airport available as an airport for public use on reasonable terms, and without unjust discrimination, to all types, kinds, and classes of aeronautical use."

I think we can agree that being charged \$11,806 per visit in addition to normal landing fees is neither reasonable or just, and is therefore a violation of the FAA grant assurance agreement.

It would be in the best interest of Friedman Memorial Alrport to provide an area for passenger drop-off and pick-up outside of the Atlantic Aviation ramp so that operators do not have to pay charges like this. Is this a possibility? Failing that, convincing Atlantic Aviation to lower the charges significantly would be in order.

Recommendation of Award

Dear Mr. Burke

Sealed bids for the Construct GA Terminal/Pilot's Lounge project at the Friedman Memorial Airport were received and publicly opened on Wednesday, July 16, 2025 at 2:00 PM as specified in the contract documents. Two (2) bids were received. The bids are summarized in the following table:

The apparent low bid was from Petersen Brothers Construction in the amount of \$1,250,000. The engineer's estimate for this project was \$1,100,000. Upon review of the bid submitted by Peterson Brothers Construction, there were several items noted that were not in conformance with the bid submittal requirements.

First, the Idaho Public Works Contractor License number provided on their bid form (RCE-9199) is not a valid number. The number provided is an inactive Idaho Contractor's License number. Upon further investigation, it was determined by searching public records that Peterson Brothers Construction does hold a valid Idaho Public Works Contractor License (PWC-C-14977) of the appropriate class for the bid submitted.

Second, Peterson Brothers Construction failed to submit Exhibit IV – DBE Utilization per the Instructions to Bidders. They did submit Exhibit V – DBE Letter of Intent indicating they did not intend to use any DBE subcontractors or suppliers on the project.

Third, they submitted Exhibit VI – Certification of Buy American Compliance indicating 100% of the steel and manufactured products would be US domestic products. While there are US domestic products available for most of the materials required for the

project, the specified security cameras and networking equipment are not manufactured in the US and without a waiver, the contractor will likely not be able to comply with the Buy American requirements.

After consultation with legal counsel on the deficiencies, it is our opinion that the bid submitted by Peterson Brothers Construction is non-responsive.

The bid submitted by Conrad Brothers of Idaho was also reviewed for bid submittal requirements. Conrad Brothers of Idaho has a valid Idaho Public Works Contractors license of the appropriate class for the amount of their bid. Conrad Brother of Idaho submitted all required bid documents. There is no published contract DBE goal for this project and Conrad Brothers of Idaho is not a DBE contractor and did not indicate they plan to subcontract to a DBE subcontractor or supplier. Conrad Brothers of Idaho did indicate they cannot comply with the 100% Buy American requirement and will need to request a Type III or IV waiver from the FAA. The System for Award Management (SAM) website was checked, and Conrad Brothers of Idaho has not been debarred or suspended from award of contracts using federal funds.

Based on the evaluation of the bids, Ardurra recommends the award of the project to Conrad Brothers of Idaho, Inc. in the total amount of \$1,386,125 subject to the FAA approving the Buy American waiver request. This award should also be made contingent on FAA concurrence with the award recommendation and the availability of federal funds.
